Executive Summary:

- Diverse stakeholders, including service providers and community members with lived experience, provided input on disparities and inequities in health and social outcomes during disasters.
- Key issues identified include lack of accessible/affordable transportation, especially in rural areas, and staff perceptions/attitudes not accommodating the needs of people with disabilities.
- Demographic data analysis, surveys of providers and clients, and task force input are being compiled to conduct a root cause analysis and identify priority areas for action.
- New members are encouraged to complete surveys to share their lived experiences.

Overview of the Project

- Purpose: To gather input from diverse stakeholders (service providers, community members with lived experience) to identify disparities and inequities in health and social outcomes during disasters.
- Methodology:
 - o a. Task force input
 - o b. Analysis of demographic/social vulnerability data
 - o c. Surveys of providers and clients/service recipients

Gathering Input from Task Force

- Experiences accessing services (health care, emergency services, etc.) during disasters:
 - Discussed barriers such as:
 - a. Lack of safety protocols
 - b. Lack of accessible/affordable transportation
 - c. Staff perceptions/attitudes treating needs as annoying or not accommodating
 - Caryn Bingham shared challenges with accessing transportation and medical appointments, especially in rural areas like Refugio.
 - She lives 40-50 minutes away from major trauma centers.

- Often has to wait 3-4 weeks for doctor's appointments for herself and 1-1.5 weeks for her children.
- Importance of getting input from diverse experiences, including lived experiences, was emphasized.

Review of Data Analysis

- Demographic data:
 - o Social determinants of health, risk factors, etc.
 - Social vulnerability analysis
- Survey results from providers:
 - o Identified priority areas and training needs
- Survey results from clients/service recipients:
 - Experiences during evacuations
 - Communication barriers
 - o Preparedness levels
- Root cause analysis being compiled from:
 - o a. Demographic data sources (Census, local reports like CRSTAS, CA-CAST)
 - o b. Survey data
 - o c. Task force input
 - Still needs to record all comments from previous meetings

Next Steps

- Finalize root cause analysis by end of month
- Task force members to:
 - Complete surveys
 - o Provide additional local data sources
- Plan next meeting to discuss priorities and action planning
